

Guide-Outfitter Contract

Alaska State Law (AS 08.54.680 and 12 AAC 75.260) requires a Big Game Registered Guide-Outfitter to provide a written Contract to document services being provided and items for which the Client is responsible.

A Contract shall be delivered to the Client within 90 days after receipt of deposit or before services are provided.

days, early success, transportation delays or early departure will be made, as well as no extra cost will be charged for longer stays should these delays keep the Client in the field or Lodge for longer than contracted; travel insurance is strongly recommended.

In the event of cancellation by the Client more than 120 days prior to the start of our hunting season, deposits shall be transferred to another hunt with us, or the deposit may be transferred to another mutually acceptable hunter secured by the Client. In the event of a cancellation less than 120 days prior to our season, deposits shall be forfeited unless transferred to a mutually acceptable hunter secured by the Client. By signing below, Client acknowledges that this is a contract for only a hunt – Stephan Lake Adventures cannot make any guarantees as to the success of any hunt. Refund requests will be denied for any unsuccessful hunts.

Other acknowledgements:

- a. It is the responsibility of the clients to ensure they are in adequate physical condition to undertake the physical demands of the hunting activity they are contracted for.
- b. If a client elects to terminate the hunt, arrangements will be made to return the client to Anchorage, as soon as possible. The hunt is over.
- c. If the client elects to relocate his camp or decides to return to the lodge during the hunt or if the client needs additional flights for special requests or for inadequate equipment replacements all associated costs will be added to the hunt cost.
- d. Flights to and from camp will be arranged as the Lodge Manager and Pilot can schedule them, but will be dependent upon weather, time of day, location and other flight needs. (i.e. meat removal)

Waiver and Release Agreement

I acknowledge that hunting, fishing, hiking, shooting etc., has inherent risks, hazards, and dangers that can't be eliminated, particularly in a wilderness environment.

I – the Client and Registered Guide – Outfitter, for myself, my heirs, successors, and executors, hereby waive and release, indemnify & hold harmless Stephan Lake Adventures, LLC, Stephan lake Holdings, LLC their directors, officers, related corporations, agents, employees, and volunteers from and against any and all claims, actions, causes of action, liabilities, or suits connected with my participation in this activity.
